Properties are valued as of January 1.

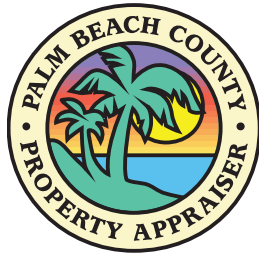
