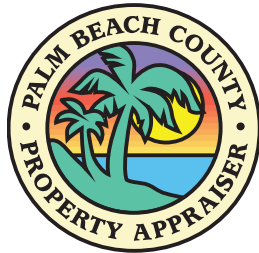

These amounts are based on last year's budgets and your current assessment.
