Properties are valued as of January 1.

If the Property Appraiser's office is unable to resolve the matter as to market value, classification, or an exemption, you may file a petition for adjustment with the Value Adjustment Board. * Due to the passage of Amendment 5 in 2024, the amount of additional homestead exemption will increase with the rate of inflation.
